THIS AGREEMENT made on the day of 20th February, 2018 between Deputy Secretary (Admin-3), Building # 6, Level-13, Ministry of Environment & Forests, Bangladesh Secretariat, Dhaka (hereinafter called "the Procuring Entity") on behalf Ministry of Environment & Forests of the ONE PART

and

Unique Business Systems Ltd, Concord Modhumoti Plaza, House#11 (4th &6th Floor), Road#11, Block#G, Banani, Dhaka-1213, (hereinafter called "the Supplier") of the OTHER PART

- In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and related services and to remedy any defects there in conformity in all respects with the provisions of the Contract.
- The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and related services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
