

**Government Order**

- a. The period of their conference and the time spent for travel and transit will be treated as on duty.
  - b. They will draw their pay and allowances in local currency. No part of it should be drawn in foreign currency.
  - c. All expenses of their participation in the said conference will be borne by the organizer. If the organizer does not bear the expenses according to their entitlement rest expenses will be borne from the GoB fund.
  - d. They will not be allowed to stay abroad more than the approved period (excluding travel time).
  - e. They will have to submit a report about the conference to the Ministry of Environment and Forests within 10 (ten) days after their return from the conference.
