Government Order


Subject: Government Order for participation in the "Global Shark Conservation Workshop" to be held from 25st to 26nd September 2022 at Maldives.

The undersigned is directed to convey the approval of the Government of the People's Republic of Bangladesh in favour of Mr. Md.
