 - d. He will not be allowed to stay abroad more than the approved period (excluding travel time).
 - e. He will submit a report to this Ministry after completion of the said travel.
2. This order is issued with the approval of the competent authority.
3. Mr. Abdul Hai will carry one diplomatic passport and eight official passports to India for obtaining the visas of Mexico and Peru as there is no any Mission of the said countries in Dhaka Bangladesh.
