3. Other terms and conditions of this Government order are as follows:

- He will draw his pay and allowances in local currency during the aforesaid period. No part of it should be drawn in foreign currency;
- All expenses in connection with his participation in the said event will be borne from his own source;
- He will not stay abroad beyond the approved period (excluding travel time);

Mrs. Tasmima Hossain (Holding Bangladesh Passport No.DC 0000931), wife of H.E.Mr. Anwar Hossain, Hon'ble Minister, Ministry of Environment and Forests (MoEF), Government of Bangladesh will be travelling as entourage of Hon'ble Minister in the aforesaid programme. The cost incurred for the travel of Mrs. Tasmima Hossain will be borne by her own financial arrangement. There will be no financial involvement of Bangladesh Government in it.
