

2. Terms and conditions:

- They will draw their pay and allowances in local currency; **there will be no financial involvement of Bangladesh Government;**
- United Nations Office on Drugs and Crime (UNODC) will bear all expenses of the aforesaid training;
- They will not be allowed to stay abroad more than the approved period (except travel time);
- They shall return to their respective workplace immediately after returning from the training; and
- They will have to submit reports on the training to the Admin-2 section of the Ministry of Environment, Forest and Climate Change within seven days after their return from the training.
