

Subject : **Government Order (G.O) for Deputation.**

The undersigned is directed to convey the Government's sanction of deputation to Mr. Md. Najmus Sayadat Pitol, Research Officer, Bangladesh Forest Research Institute (BFRI), Chattogram, Ministry of Environment, Forest and Climate Change, Government of the People's Republic of Bangladesh to attend the Postgraduate Program in Tropical Marine Sciences (PPGCMT) at Federal University of Ceara (UFC), Fortaleza, Brazil for 04 (Four) years during March 2024 to February 2028 or from the date of commencement of leave under the following terms and conditions:

- (i) The entire period of the programme and the time spent for travel and transit will be treated as on duty;
- (ii) He will draw his pay and allowances in local currency during the aforesaid period;
- (iii) The relevant expenses in connections with this study will be borne by Federal University of Ceara (UFC), Fortaleza, Brazil;
- (iv) The provision of Appendix V and Rule 194 of BSR (Part-1) is applicable for this approval;
- (v) He will not be allowed to stay abroad more than the approved period (excluding travel time);
- (vi) He will have to submit a report on the acquired experiences to this Ministry within 07 days after his return;
- (vii) He is requested to sign a bond in prescribed form before his departure;
- (viii) He is ineligible to apply for permanent residency and citizenship while studying abroad;
- (ix) All terms and conditions of Public Administration Training and Higher Education Policy, 2023 and other related Rules and Regulations for training/studying abroad will be applicable.
